

# India ASEAN Startup Summit Pitch Competition Terms and Conditions

#### A. Introduction

The present document defines the India ASEAN Startup Summit (IASS) Pitch Competition (the "Competition") terms and conditions (hereafter "the Competition T&Cs"). It describes the rules that relate to the application and functioning of the Competition.

## **B. About IASS Pitch Competition**

India ASEAN Startup Summit is organised by DEWI Wealth Accelerator Sdn Bhd, together with CoExerts and Input Startegy Sdn Bhd. Supported by many organisations. IASS Pitch Competition is part of the highlights of the summit, to showcase startups and create opportunities to get funded.

# C. Pitch Participation and Eligibility

- 1. Be enrolled as delegate of India ASEAN Startup Summit
- 2. Each applicant must be over eighteen (18) years of age and income generating startup
- 3. All Pitch submission to be email to <a href="mailto:iasspitch@gmail.com">iasspitch@gmail.com</a> to qualify for the competition
- 4. The closing date for pitch submission is Dec3th 2023
- 5.By participating, the applicant agrees to be fully and unconditionally bound by these Competition T&Cs and represents and warrants that it meets the eligibility requirements. In addition, the applicant agrees to accept the Organisers' decisions relating to the content of this Competition as final and binding.
- 6. The Organisers have the right to verify the eligibility of each Applicant. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Organisers.
- 7.If the applicant uses fraudulent methods or otherwise attempts to circumvent the rules, its submission may be removed from eligibility at the sole discretion of the Organisers. Any part of the pitch or applications found to be plagiarized, offensive, or unethical may be screened & disqualified.
- **D. Prizes** There are "in-kind" prizes, trophies and certificates to be presented to the top 5 Winners of the Competition.
- 1. Top 5 will receive the GOGLOBAL Accelerator Program with Lifetime Global Membership worth USD1800
- 2. Top 3 will receive Publicity Media Coverage Worth USD500
- 3. Top 3 will also be featured in the Global Invest Platform home page Worth USD500

## E. The Competition Consists of Two Rounds

- 1. Round One conducted over 3 sessions Dec4th, Dec6th and Dec9th, via Streamyard, over Social Media of the IASS pages.
- 2. All pitches to be conducted within 6mins with 3 mins Q&A by jury
- 3. First round conducted with the Jury, online, judged according to Business Viability, Market Potential, Financial projections and overall conviction of the founder. Knowledge of intellectual property assets Overall attractiveness of the opportunity
- 4. Feedback will be provided to each participating founder
- 5 Founders will be selected by the judges to participate in the Final Round and notifications provided by December  $10^{th}\ 2023$

#### 6. Final Round

Founders that qualifies for the final round is required to present their pitch to a panel of judges, on the Dec13th 2023, Gala Dinner Event during the India ASEAN Startup Summit. This constitutes the Final Public Presentation. Feedback will be provided to each participating team.

# F: Intellectual property

- a. The applicants understand and agree that the Organisers, anyone acting on behalf of the Organiser, and the Organiser's licensees, successors, and assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity, without limitation, the applicant's entry, name, portrait, picture, voice, likeness, image, statements about the Competition, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes, without any further compensation, notice, review, or consent.
- b. By submitting his/her application, any applicant represents and warrants that the content of the application is an original work of authorship and does not violate any third party's proprietary or intellectual property rights. If an entry of any applicant infringes upon the intellectual property right of another, he/she will be disqualified at the sole discretion of the Organisers.
- c. If the content of the entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, the applicant shall, at his/her sole expense, defend or settle against such claims. The applicant shall indemnify, defend, and hold harmless the Organisers from and against any suit, proceeding, claims, liabilities, loss, damage, costs or expenses, which the Organisers may incur, suffer, or be required to pay arising out of such infringement or suspected infringement of any third party's right.
- d. Applicants are fully responsible at all time for the protection of their intellectual property within the framework within their participation in the Competition.

## G: Limitation of liability.

By applying, the applicant agrees to release and hold harmless the Organisers and their subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) the applicant's participation in the Competition and/or its acceptance, possession, use, or misuse of the Prizes or; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Competition.
